## Conditions of participation

### Prize competition

### Organizer

Rules of the competition

### Conditions of the competition

Participants sign up for a series of emails from the Move More campaign. The invitation will go out to existing customers as an email on the 29<sup>th</sup> of February. After registration you will receive 5 emails in 5 weeks. Each email must be opened within 6 days of receipt. Only then will the participant receive a quiz at the end with 5 questions about the 5 emails. If all these questions are answered correctly, the participant ends up in the lottery pot. A random draw will take place on 15.5.2024.

### No obligation to purchase

Participation in the competition does not oblige participants to enter into purchase contracts or to make use of the organizer's services.

### Drawing procedure

The winner will be decided by lottery on 15.5. 2024. This will be carried out digitally. Each participant will be assigned a number, which will then be drawn using <https://www.random.org/lists/>.

### The prize

The organizer will give away 4 office chairs to four winners.

Winners will be drawn from two different regions:
