







## **Haworth Product Compliance Guidance**

#### **Formaldehyde**

Haworth products listed are GREENGUARD certified and meet the Healthy Interiors criteria for low formaldehyde emitting. These products have been tested in accordance with ANSI/BIFMA Standard Method M7.1-2011 (R2016) and comply with ANSI/BIFMA e3-2014 Furniture Sustainability Standard, credits 7.6.1 and 7.6.2.

#### Per- & Poly-Fluorinated Compounds (PFCs)

Most standard Haworth fabrics do not contain PFC-based, stain- and water-repellant treatments, unless treatment is specified by the customer. A list of fabrics that meet Healthy Interiors criteria and Haworth performance standards is available at surfaces. haworth.com/resources.

Customers are responsible for COM fabric treatments and chemical content.

#### Flame Retardants

Haworth products listed meet the Healthy Interiors criteria for flame retardants, excluding CAL133 specifications.

Customers are responsible for COM treatments and chemical content.

#### Polyvinyl Chloride (PVC)

Haworth products listed are PVC-free with the following exceptions:

Certain products include PVC material associated with electrical components. PVC content is less than 1% of the total product weight, which meets the Healthier Hospitals guideline exemption.

Compliance excludes vinyl (PVC) finishes.

Customers are responsible for COM fabrics.

#### **Antimicrobials**

Most Haworth fabrics are antimicrobial free unless treatment is specified by the customer. A list of fabrics that meet Healthy Interiors criteria as well as Haworth performance standards is available at surfaces. haworth.com/resources.

Surface finishes associated with Haworth Health Environments products may contain an antimicrobial additive for the sole purpose of preserving the product, which is acceptable by the Healthy Interiors criteria. Customers do have the choice of specifying products

free of this antimicrobial additive.
